
Review Report to BISIL PLAST LIMITED.

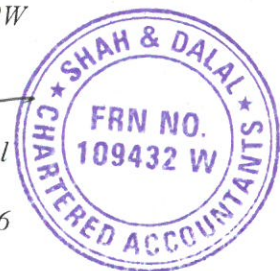
